# Assisting with the day-to-day running of the retail operations of all commercial outlets at One Garden Brighton. This includes barista duties, customer service, stock replenishment, and managing and maintaining excellent presentation standards in the shop and bakery. You will also assist with other aspects of the commercial offer within the Walled Garden and surrounding grounds and support our busy events programme. Utilising the EPOS and till system to serve customers

- Opening and closing checklists at the start and end of shifts
- Maintaining good standards of food hygiene and safety within the working environment logging and adhering to protocols and processes when required
- Working with the Supervisor and Manager to ensure the One Garden Brighton offer and ethos is upheld.
- Confidently liaising with visitors to One Garden Brighton to ensure they are enjoying an excellent customer service experience
- Delivering expert knowledge of the products, events and experiences available at One Garden Brighton
- Serving customers and upselling any products identified by the Manager/ Supervisor

### **Working Hours**

Hours of work will vary but are generally based around the One Garden Brighton operating and opening times of 8.00am to 6.00pm. Some flexibility will be required to meet the needs of the business, so this will also include some evening working for functions and events and whole college promotional events. One Garden Brighton is open all year round, generally seven days per week but there is some flexibility around winter operational times.

### **Continuous Professional Development (CPD)**

This post will be entitled to CPD for skills updating, personal and professional development. All CPD must be planned, agreed, and booked with your Line Manager.

### **Pension**

The candidate appointed to the post may become a member of the One Garden Brighton Pension Scheme and pay contributions as determined by annual salary levels.

### **Equality and Diversity**

### **Criminal Record Check via the Disclosure Procedure**

The Rehabilitation of Offenders Act 1974 gives individuals the right not to disclose details of certain old offences when asked about their criminal record as they may be defined as 'spent'. The DBS Disclosure will also indicate whether information is held on government faculty lists of those individuals who are barred from working with children or vulnerable adults (if applicable).
