Job Purpose

The Lead Instructor is responsible for the organisation, planning, instructing and assessing students in a range of practical tasks relating to animal care whilst also, providing daily operational support to the Animal Management Centre and, where required, within the faculty (Animal Management, Equine, Veterinary Nursing and Adventurous Activities Faculty).

It is the responsibility of the lead instructor to liaise with the programme managers and coordinate the delivery of the practical lessons and to develop the practical curriculum and enrichment for all learners. The role includes providing specific one-to-one and group student support within both the practical and theoretical learning environment.

Duties and Responsibilities of the Job

1. Teaching, Learning and Assessment

- a. As coordinated by the Programme Managers and Curriculum Manager, plan, prepare, teach, assess, report and monitor to ensure each highly effective lessons to a consistently good or outstanding standard. Share teaching, learning and assessment (TLA) good practice and celebrate students' and others' successes.
- b. Liaise with the Animal Collections Manager to coordinate the Instructor delivery of practical sessions and routine sessions (including routines and commitments out of term time).
- c. Conduct initial assessments and record within the Student Individual Learning Plan, adapt teaching delivery to meet the requirements of the plan and monitor student progress frequently and report to programme Manager.

- d. Ensure opportunities are created and realised for students to be able to continuously develop their English and maths skills.
- e. Work to ensure high levels of student attendance in all sessions and prompt completion of registers.
- f. Prepare and effectively use schemes of work and lesson plans in line with college processes.
- g. Coordinate bookings relating to AMC usage and ensure resources are booked in advance of requirements e.g. classroom, animal rooms/sections, animals for handling, grooming equipment etc.
- h. Where practically applicable, use and apply modern technology in TLA to enhance the learning experience and support progress for students, eg PoL, specialist software/resources, working to the college VLE standards.
- i. Create and deliver engaging, relevant and innovative practical lessons ensuring that all aspects of the practical modules are met whilst upholding high animal welfare standards.
- j. Ensure cohesive assessment plans are in place for all students across your allocated teaching to ensure effective student progress.
- k. Set exams, homework and extension activities for individual students and provide timely, and constructive feedback to students to support progress.
- I. Mark and assess course work and provide effective verbal and/or written feedback to support progression in line with awarding organisation requirements and college processes.
- m. Monitor tracking of individual student progress across programme(s) and ensure action is taken to improve progress where possible.

Working Hours

Basic working hours are from 0830hrs to 1700hrs Monday to Friday but some flexibility will be required to meet the needs of the business. This is an all year round post. There will be some evening and weekend working required to support department and whole college events where there will be a requirement to attend.

Annual Leave
