

2019-20 access and participation plan monitoring Provider impact report

This impact report summarises the progress made by Plumpton College against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

Plumpton College's ambition and strategy as detailed in the 2019-20 access and participation plan:

Plumpton College is a specialist land-based college, which offers both Further and Higher Education courses. The college's 2019-20 Access and Participation Plan focused on improving access, success and progression for target groups who at the time of writing were under-represented in the HE student body. It should be noted that changes to HE provision through the reduction of courses offered and a focus of resources on priority curriculum areas means that HE numbers have reduced significantly. This has had an impact on the validity of year-on-year analysis of trends within the college's HE student body.

Access

The plan focused on improving internal progression from FE to HE, increasing numbers of students from low participation neighborhoods, increasing numbers of non-white students, and raising attainment in schools.

Success

The plan aimed to increase success rates for disabled students, mature students and students from non-traditional backgrounds.

Progression

Improved progression for all HE students was to be facilitated by extracurricular programmes, a more robust placement module, improved careers guidance and improved progression from Foundation degree to top-up, and from Bachelors to Masters.
